## Lady Indians Are Bowling Green Tournament Champions Again After 34 Years

For the first time since 1988, the Van-Far Lady Indians have taken home the Bowling Green Basketball Tournament's championship hardware.

Van-Far faced some tough competition from the start of Bowling Green High School's 97th annual invitational. They went into the tournament with only five wins. Despite coming off a fresh loss against Monroe City and sporting a 5-10 record, the Lady Indians were placed as the fourth seed.

They were also slated to go up against North Callaway first. A team they defeated by 10-points before the Christmas break. A good start for certain, but they were far from favored to win the entire thing with teams like 11-6 Elsberry, 10-6 Clifton, and 10-5 Silex in the bracket.

Both Elsberry and Silex handed Van-Far losses earlier in the season. But Van-Far Head Basketball Coach, Heather Minter, and the Lady Indians were progressively improving, and their tenacity hadn't gone unnoticed by other teams.

"We've got to keep Mara on the floor," Minter told the Tribune after their semi-final match against Elsberry. "A lot of teams know that's where we're going. they're figuring

that out. So, I feel like once the other girls start taking shots, that will open things up for us."

And that's exactly what they did. Coach Minter's got her message through to the team because they moved the ball more frequently and took better aimed shots which often scored.

"These ladies were capable, and I knew they could do," Minter said of the championship game. "I told them the keys are knocking down shots, taking care of the ball, communication, and having fun. The only thing I worried about was if they would freak out with the large crowd. This is about these kids believing and getting some respect back for the girl's program. I have really enjoyed sitting back watching their excitement and them grow together as a team."

It was much more precise game for the Lady Indians than the one they played against Elsberry. Where Minter felt they played a little sloppy in the semi-finals, the Van-Far ladies worked the ball more methodically taking shots which allowed Mara Jensen to snag the rebound when they did miss the net.

In the game against Silex, the team worked together with playmaker Devyn Keller methodically moving the ball forward and setting

up the top scorers of the night. From watching the Van-Far senior's calm demeanor, one would never suspect it was her (and the team's) first time in a championship match.

"I have not been in a championship game since I've been in high school," Keller told the Tribune after the game. "It was definitely something I've never felt before. I love the atmosphere and the support we had from the student section. It was all amazing."

Sophomore, Carmen Wilburn, agreed.

"It was a great feeling," she said when asked how it felt earning the title. "Having everyone come out and support us was great."

"The amount of communication we had definitely contributed to the win," Keller continued. "We all worked together as a team, stepped up when we needed to, and we all played the roles we needed to."

"We've been working on that all season," Wilburn answered when asked about the team finding the net. "It's been building up to everyone needing to be on the same page and clicking. We really got on a roll tonight."

Mara Jensen had a huge night racking up 27 points – half of the teams combined total score. She was followed by Haley Baskett who put

## To Save The Union

### Pike Man Part Of Effort To Avoid Civil War

Editor's note: Following is part one of a story by contributing writer Brent Engel.

The task looked impossible, but Aylett Hawes Buckner took up the challenge.

The Bowling Green newspaper editor, lawyer and judge was among more than 100 delegates to the 1861 Peace Convention in Washington, D.C.

The goal was to find a compromise over slavery with which everyone could agree. In hindsight, it was wishful thinking, but the fact that such a gathering occurred at all was remarkable.

The country was in chaos, with seven states having already seceded. Neither Republicans nor Democrats were willing to compromise. There were also questions about the constitutionality of having unelected delegates dictate national policy.

Outgoing President James Buchanan supported the convention. "Convinced that Congress would not hold the Union together, he desperately reached out for any alternative that seemed even remotely plausible," wrote William J. Cooper in "We Have the War Upon Us."

President-elect Abraham Lincoln disagreed, telling a friend that "no good results" would come of it and predicting it would break up "without having accomplished anything."

John Tyler, who was almost 71 years old, came out of retirement to lead the convention. Among those accompanying the former president to Washington were his 40-year-old wife, Julia, and their eight-month-old daughter, Pearl.

Joining Buckner in the Missouri delegation were St. Charles County lawyer John D. Coalter, Liberty attorney Alexander W. Doniphan, former State Representative Harrison Hough of Charleston and former Seventh Judicial Circuit Judge Waldo P. Johnson of Osceola.

As with Buckner, most of the delegates were attorneys. Author Mark Tooley identified six former cabinet members, 19 former governors, 64 men who had served in Congress and

12 state supreme court justices.

The convention got under way at noon Feb. 4 in Willard Hall, a former Presbyterian church. Ironically, the Provisional Congress of the Confederate States of America met for the first time that day in Montgomery, Ala.

Buckner was a Democrat and staunch supporter of the 10th Amendment's guarantee that left to the states all rights which were not specifically

Court in 1838, and Pike county was the theater of his first efforts in his profession," Headley wrote.

A nasty divorce case involving Isaac Newton Bryson, the son of a Louisiana co-founder, and his wife, Margaret, propelled Buckner to legal stardom.

"The facts of that case partook more of the character of romance than real life, and it excited great interest in the eastern part of Missouri," Headley noted.

In 1841, Buckner took office as Pike County Circuit Clerk. He also married Virginia native Eliza Lewis Clark, whose father was a first cousin of famed explorer William Clark and Revolutionary War hero George Rogers Clark. Her mother was a first cousin of Meriwether Lewis.

Buckner declined to run for a second term and in 1850 moved to St. Louis.


He didn't like city life and by 1855 was back on his Pike County farm. Buckner served on the Missouri Board of Public Works and in 1857 was elected judge of the Third Judicial Circuit, which covered Pike, Lincoln, Montgomery, St. Charles and Warren counties. It was while serving in that capacity that he was chosen for the Peace Convention.

After almost two weeks, a pro-Southern package of six constitutional amendments and four Congressional resolutions was proposed. Northerners were outraged. One of the recommendations went as far as saying that Congress could make no future constitutional amendments outlawing those approved by the convention.

Delegates met with Lincoln a few days later, and it didn't go well. The president-elect adamantly said there would be no compromise on the extension of slavery, calling any attempt "surrender."

Lincoln said no concession "short of everything worth preserving and contending for" would satisfy the South. And while he still wanted peace, "it may be necessary to put the foot down."

outlined in the Constitution. He would prove his point during the convention.

As with Tyler, Buckner was a Virginia native from a prominent family. He was born at Fredericksburg on Dec. 14, 1817. His mother, Mildred, was "a woman of strong mind and extraordinary energy," according to author Phineas Camp Headley. His father, Bailey, was an officer in the American army during the War of 1812 and later worked in the Treasury Department. He was "a most brilliant and popular man," a family history reads.

Thanks to a physician uncle for whom Buckner was named, he attended Georgetown and the University of Virginia. He taught school and studied law before moving to Missouri in 1837.

"Here he acted as Deputy Sheriff and Deputy Clerk during the day and studied law at night until he was licensed to practice by the Supreme

## Jayson Orr Signs With Better Man

Big things are happening for one Van-Far alum who set his sights on the music industry. 2019 Van-Far graduate and country singer, Jayson Orr, announced earlier this month that he had signed to begin recording with the Fayette based studio Better Man Records.

"I'm so excited to announce that over the holiday I signed with Better Man Records LLC to start going to work and bringing more music to you all this year," Orr wrote in a social media post on Jan. 3, 2022. "This has been a long journey with a lot of ups and downs and to say I'm thrilled is an understatement."

As a full-time college student, he'll have a busy schedule between the studio, classroom, and his performances. But Orr's no stranger to slouch when it comes to hard work and a full schedule.

In June of 2020, he released his debut single, Southern Nights, while attending North Central Missouri College (NCMC). All the while, he continued to focus on his musical career and performed at various venues.

If Jayson looks familiar to readers who haven't seen one of his performances, that might be because he works at Walmart in Bowling Green during breaks from school. He's also performed there on occasion to help with fundraisers and charities.

In May of 2022 he graduated from NCMC with an associate degree and recently transferred to Missouri State University.

According to Orr, that's where he was when the contract from Better Man Records arrived at his home mailing address in Vandalia.

"I couldn't believe the deal was offered to me," he told the Tribune. "I really had been wanting to sign with Better Man for a while now but there were a lot of setbacks in my life that kept pushing it back. My family's reaction was what meant the most to me. Some of them knew before I did, because my parents were the ones who got the contract sent to them."

According to Orr, his family's reaction was worth all the waiting and setbacks.

"To see all of them at the end of the day believe in me and want to see me chase this dream, it means more than just songs on paper," he continued. "When the end of year came around the label reached back out to me one more time — between myself and my family, I had never

felt more ready to make this step in my life."

But now the real work begins for Orr who says he hopes to have music out sometime this Spring.

"Now that I've signed, we have already started putting a couple song projects into the works of putting them together and trying to make it the best we can," he explained. "We also have some songwriting sessions coming up. Hopefully, we'll get some music back out around springtime. I've been dying to do it for a while since going the whole year of 2021 without releasing any music and not really playing many shows throughout the year. So, when I signed on, it felt like we went to work immediately. With the process of working on a couple songs and writing like crazy it feels more like a job everyday which is the best part."

The record label and studio, Better Man Records LLC, is located in Fayette which is about 30-miles Northwest of Columbia.

The label is owned by singer/songwriter Preston Ary whose band has opened for Granger Smith, Jameson Rodgers, and Confederate Railroad.

According to the Better Man Records website, "after

learning the ins and outs of the music business in Nashville TN, they decided to bring the industry to Missouri allowing local artists the ability to experience an authentic studio feel in their own back yard as well as pursue their music careers from the Show Me State."


Fortunately, Jayson won't have to relocate from where he stays in Warrensburg to work in the studio.

"The distance I have to travel from Fayette to Warrensburg is perfect," he explained. "I can play shows on Pine Street and still only be about an hour away from the studio."

It's all part of Orr's growth as an artist while he continues his journey in the music industry. But none of it would have been possible without family, friends, and fans.

"I can't thank all the people who got me to this part of my life and how they will continue to help and motivate me along the way," he said. "I couldn't have done it without you! Thank you all and be on the lookout for some new music coming soon!"

## Representative Chad Perkins Capitol Report

### HOUSE APPROVES BILL TO SUPPORT AND PROMOTE MISSOURI AGRICULTURE (HB 1720)

The members of the Missouri House have approved legislation that will renew key programs designed to support and promote agriculture in the state. With bipartisan support, the House approved HB 1720 to continue several agriculture programs that are priorities for the agriculture community in Missouri.

In explaining the importance of the bill, the sponsor of HB 1720 noted the programs created and extended by the legislation would be responsible for creating hundreds of jobs. He pointed out that, "Agriculture is the number one revenue-producing industry in the state, generating just under \$94 billion in economic contributions. One in ten jobs in the state of Missouri are directly related to the agriculture industry."

The bill would extend existing credits available under the Missouri Agricultural and Small Business Development Authority. The sponsor noted these credits have supported projects in 103 counties and have generated direct and indirect benefits of more than \$260 million since 2000.

HB 1720 also expands the Family Farm Livestock Loan Program so that more Missouri farmers will qualify. The program is currently limited to farmers with less than \$250,000 in gross sales per year. The bill would double that amount to allow farmers with less than \$500,000 in gross sales to qualify. The bill would also double the maximum amount of the loan for each type of livestock. The loan program

has a return on investment of \$7.85 per dollar invested.

The bill creates the Ethanol Retailers Incentive to provide a tax credit to retail dealers selling higher ethanol blend at the dealer's service station, as well as a biodiesel tax credit for retail dealers selling a biodiesel blend and a credit for Missouri biodiesel producers. The bill's sponsor noted Missouri ranks in the top third of states for biodiesel consumption. The credits would go into effect Jan. 1, 2023.

The bill now moves to the Senate for consideration.

### HOUSE APPROVES BILL TO IMPROVE OPIOID ADDICTION TREATMENT AND PREVENTION SERVICES (HB 2162)

The Missouri House has given initial approval to legislation that would give the General Assembly greater flexibility when appropriating funds to fight opioid addiction. The bill was created in anticipation of a settlement with opioid distributors, and is designed to allow lawmakers to allocate funds to programs in state government that provide resources to victims of addiction.

It was in July that the Missouri Attorney General announced the state had reached a settlement with Johnson & Johnson and multiple opioid distributors. If all municipalities in Missouri sign onto the proposed settlement, the state will receive just over half a billion dollars. These funds would be used for addiction treatment, recovery, and intervention programs.

In 2020, 1,842 people in Missouri lost their lives to drug overdose. The majority (73 percent) of

the drug overdose deaths involved opioids. Supporters say HB 2162 is important to ensure the various state departments receive the funds they need to offer life-saving treatment to those battling addiction.

The bill received strong bipartisan support in the House. It requires an additional vote before moving to the Senate.

### BIPARTISAN CITIZENS COMMISSION FILES FINAL HOUSE REDISTRICTING PLAN

The House Independent Bipartisan Citizens Commission recently approved a final state redistricting plan. The final plan, which was approved unanimously by all 20 commission members, is the first plan approved by a House Commission since 1991.

The final redistricting plan has an overall difference in population of 5.8 percent between its largest and smallest districts. The commission has posted the final plan for public viewing and can be accessed from the Redistricting Office's website at <https://oa.mo.gov/budget-planning/redistricting-office>. The page will include an interactive map as well as the official filing documents submitted to the Secretary of State, and other supplemental maps and tables.

The Senate Independent Bipartisan Citizens Commission failed to submit a tentative plan to the Secretary of State's office by the Dec. 23, 2021 deadline. Per the Missouri Constitution, the Missouri Senate will now be redistricted by a new commission of six members appointed from among the judges of the appellate courts by the Missouri Supreme Court.



I selected this book because it was chosen by librarians as the #1 LibraryReads "Favorite of Favorites" for 2016 and I hadn't read it yet. It did not disappoint. It is a riveting mystery that earned Ware many comparisons to Agatha Christie.

Travel journalist Laura "Lo" Blacklock has an unexpected opportunity to go on the maiden voyage of a luxury cruise ship. If all goes well, it could mean a promotion. Lo has some personal issues which make others view her as a less than reliable witness to what she says was a murder on the ship. She's sure she saw someone thrown overboard in the middle of the night, but no passengers are missing and there is no evidence to support what she thinks she saw. She was seen publicly drinking way too much just hours prior to the supposed incident and hadn't had enough sleep, so maybe it was a dream.

Lo is determined to prove that she is right and bring justice for the victim. Everyone on the ship becomes a suspect in her eyes. But the deeper she digs, the more dangerous the stakes, and Lo could end up losing much more than just the promotion she was hoping to get from this trip.



## MDC Reports Final Deer Harvest For Season More Than 293,600

Missouri's 2021-2022 deer-hunting season ended Jan. 15 with the Missouri Department of Conservation (MDC) reporting a preliminary total deer harvest for the season of 293,670. Of the deer harvested, 143,049 were antlered bucks, 26,599 were button bucks, and 124,022 were does.

Top harvest counties for the overall deer season were Franklin with 6,392 deer harvested, Texas with 5,478, and Callaway with 5,452.

Hunters harvested 297,214 deer during the 2020-2021 deer hunting season with 140,855 being antlered bucks, 28,652 being button bucks, and 127,707 being does.

"This year's harvest total was slightly behind last year's mark and about three percent above the previous five-year average," said MDC Cervid Program Supervisor Jason Isabelle. "We've seen an increasing trend in statewide deer harvest for about the past eight years," said Isabelle. "The deer population has continued to increase across much of southern Missouri at the same time that we've seen a population recovery in most of the counties impacted by the severe hemorrhagic disease outbreak that occurred in 2012."

**ARCHERY DEER RESULTS**  
Deer hunting ended with the close of the archery season. Preliminary data

from MDC showed that hunters checked 60,834 deer during the 2021-2022 archery deer season making it the third highest archery deer harvest on record. Top counties for the archery deer season were Jefferson with 1,563 deer harvested, St. Louis with 1,368, and Franklin with 1,274.

Hunters checked 67,487 deer during the 2020-2021 archery deer season. This year's archery deer harvest total was 10% below last year's record harvest and 8% higher than the previous five-year average.




