Henderson's Repose Unfazed By Impeachment Arm-Twisting

Editor's note: The following is the third part of a story by Louisiana author Brent Engel about the role of Pike County lawmaker John Brooks Henderson in the 1868 impeachment trial of President Andrew

Henderson Brooks remained steady as the political world spun out of control during the 1868 impeachment of President Andrew Johnson. Only once did the U.S. Senator

from Pike County even remotely show a sign of bowing to pres-sure, and he quickly – and very eloquently – reversed course.

Henderson certainly didn't waste anyHenderson assured col-leagues he did not think Presidents "may in mere wantonness violate or disregard" any statute, but said each case should

be judged individually.
"If the President's purpose be criminal and corrupt, he should be removed," Henderson added. "If he honestly intended only to procure what he says in this case (was) a judicial construction of a doubtful law - doubtful not only in its terms, but in its constitutionality - what right have we to pronounce him guilty of high crime?"

Henderson also criticized exclusion of some testimony, pointed out that previous Presidents had taken similar actions and that, technically, Stanton still held office because he had refused to comply with Johnson's dismissal.

The Learning Center Still Strong After 48 Years

In the 1970's, citizens of Bowling Green determined that children with a disability needed a preschool. Through the hard preschool. Through the hard work and dreams of many citi-zens, The Learning Center was established. It has had different locations and formats but at its core was always the hope that children with disabilities would have access to a quality education.

Today, The Learning Center (TLC) is a not-for-profit private preschool in Bowling Green

which is operated by the Champ Clark Association for Challenged Children, Inc. From the basement of a house at Ruth Jensen Village to its present location on Business 61, TLC has grown and expanded to now serve children of all abilities in an inclusive environment. That is, they all work and play together.

For those children who qualify, TLC provides physical, occupa-tional, speech, language and developmental therapy as well as transportation. TLC maintains a low staff to student ratio with some students receiving one on one assistance.

TLC's mission is to provide a safe, nurturing environment which includes all children and motivates them to explore, create and learn, regardless of their abil-ities. TLC is steadfast in its commitment to support each child's individual stages of learning, including his or her physical,

and sagacity," wrote historian William Fortune. "He possessed great force of character and had a manner of making loyal friends and bitter enemies.

Boon was elected lieutenant governor in 1819 and served in the top job for three months between the resignation of resignation of Jonathan Jennings and the inau-gural of William Hendricks. Voters sent him to Congress in 1824.

"I shall carry with me, into whatever situation I may be placed, a grateful recollection of the civilities which I have received from many of you, and of the almost unlimited confidence which has been reposed in me by a generous public," he

Boon lost a re-election bid in 1826, but used the time to build the Democrat Party in Indiana. He was elected to Congress again in 1828 and served until being

defeated 10 years later.
In 1839, Boon and his family moved to Louisiana in Pike County

"In Missouri, Governor Boon at once became active in public affairs, and soon was one of the leading men of the State," author William Wesley Woollen wrote. Even though both were huge

supporters of Democrat President Andrew Jackson, Boon soon Andrew Jackson, Boon soon crossed paths with Thomas Hart Benton, the kind of machine politician comparable in later years to those of Tammany Hall in

Benton "was then the political dictator of Missouri, and controlled its politics as absolutely as any feudal lord controlled the action of his dependents," Woollen told readers. "A rebellion against the autocratic rule of Benton was inaugurated, and Boon became its principal leader." In January 1844, Missouri

Democrat Party leaders wrote to Boon, saying they had heard he was interested in another run for Congress and asking his opinions on the issues. Boon proved astute and offered a broad appeal, saying he was "a Democrat of the true Jeffersonian stamp."

"Whilst I am insensible of having authorized the use of my name as an aspirant to any office at the next August election, I am, nevertheless, proud of the opportunity thus afforded me to express my sentiments touching some of the leading questions of political economy, about which there exists so great a diversity of opinions among the De Missouri," he wrote. Democrats

Boon finally decided to run in a race that featured more than eight other candidates, including Pike County resident D.C. M. Parsons,

an Ashley store owner. Woollen said Boon "espoused the measures of reform then in agitation" across Missouri and "gave them the momentum that (eventually) insured them success," but the race "became exceedingly bitter between the reformers and the adherents of Benton.

Though accounts don't give details, Boon was forced by illness to drop out of the race. Democrat slave owner, future governor and Confederate general sterling Price was elected.

Boon died at his Louisiana home on Nov. 20, 1844, knowing that Jackson protégé James Polk had been elected President. He and his wife, Delilah, who died four years later, are buried in Louisiana's Riverview Cemetery.

Though a slave owner, Benton switched his position on the issue to such a degree that state legislators did not return him to the Senate in 1851 after 30 years of service. He died April 10, 1858, and is buried in St. Louis.

N.P. Minor of Louisiana called Boon "a born partisan (who) loved his friends and hated his enemies, but at heart he was too honest and independent to fawn on any man" and was "always ready to strike heavy blows for what he thought was right."

Woollen also offered a tribute.

"He belonged to a type of men suited to frontier life, and his career, both in Indiana and Missouri, was that of a coura-geous and self-reliant man," Woollen said. "He was a pioneer of two states, and he left his impress upon them both."

We told the boys it wasn't panic mode yet. We wanted to keep getting stops defensively and wanted to start attacking the rim. With about 3:30 to go we started our run. We got a couple of quick shots and a couple of steals and cut into their lead."

Milan struggled with Van-Far's traps and the team rotated very well and started to capitalize on the turnovers.

"We got a steal and a layup to tie the game at 47 and then Caden had a huge defensive stop and we took possession with the intent to take the last shot of the game. Our execution wasn't perfect so we called our final timeout with 3.5 seconds to go. We drew up a quick set to try and get Lathyn on a back door and if it wasn't there Trey was supposed to "go to work" and win the game. Unfortunately we didn't get what we wanted so we headed to overtime."

Despite Milan getting the two point lead first in OT, momentum was in Van-Far's hands.

"I can't say enough about all of our kids and their will to win. There is no quit in these boys and they kept grinding it out and found a way to get back into the game and eventually pull it out. It was a total team win! Our bench was tremendous. Treyson, Colten, Verlyn, and Colin all played big minutes. They kept us in the game and allowed us to sub in and out to protect Lathyn and Trey who both had 4 fouls most of the 2nd half and OT. Defensively we gave up 23 points in 20 minutes of basketball. That effort allowed us to come back," Connaway said.

"Our fans and crowd were magnificent. There was a sea of black and gold in the stands and they willed these boys to a victory and now we're on to the Final Four for the first time since 2004," he added.

"Now we have to face Mid-Buchanan who is ranked #2 in the state and who just defeated the #1 ranked team in Sacred Heart. It will be a very tough match-up for us. They are very athletic and crash the boards hard. I know one thing, we are going to show up, play hard and give it all we have. It's a great day to be and Indian and we'll see everyone this Thursday at 8:30 p.m. at JQH Arena in Springfield."



"Now we have a wireless sensor chip available called 'CardioMEMS' which is implanted in a pulmonary artery. Sports Modot Asking For Farmer's Help

one of the major contributors to many of the world's food sources. From livestock and grain to veg-etables and fruits, among other commodities, the state is fortunate to have good land, growers and farmers to keep our economy strong and people fed.

The Missouri Department of Transportation is asking for help from our residents and businesses who produce and cultivate these commodities. The message is simple: please refrain from planting crops on the state right of way. "We work very closely with farmers and area residents to ensure the state right of way is maintained to meet or exceed standards necessary to keep it safe and free from erosion," said MoDOT Maintenance and Traffic Engineer Jennifer Hinson, P.E.

Hinson went on to explain how planting onto the right of way, next to state maintained highways, can cause problems. "We get sev-eral calls each year about drivers not being able to see at an inter-

because crops have been planted far into our right of way, close or into ditches," she explained. The into ditches," she explained. The crops, especially tall plants like corn or milo, create a sight distance issue for drivers at a stop sign, making it difficult for them to pull out safely.

Another reason it is important crops are not planted on the right of way is because it creates ero-sion, filling ditches next to the highway that have the purpose of keeping water off the road. "When we see land that has been planted, we try to contact the landowner, but that is not always successful, and also what we have learned is many times this land has been rented out to another farmer, so it is difficult to get directly in touch with the renter," she explained.

Hinson said when encroach-

but to cut down the crops, especially when it involves sight dis-tance. "We also set out flags to mark the right of way line when we notice encroachment," she explained.

"We just want everyone to be safe and to reduce the amount of erosion in our ditches, which causes extra work for our crews," she added.

she added.

She encourages area residents to contact MoDOT customer service at 1-888 ASK MODOT (1-888-275-6636) if they notice any crops that have been planted on the right of way. "While there are no specific legal ramifications for this type of percencephaget, it can this type of encroachment, it can have an impact on safety, so we hope by making people aware of the problem, we can eliminate or at least reduce it," she said.



10 Ways To Love Your Brain

Growing evidence indicates that people can reduce their risk of cognitive decline by adopting key lifestyle habits. When possible, combine these habits to achieve maximum benefit for the brain and body. Start now. It's never too late or too early to incorporate healthy habits.

Break a sweat – engage in reg-ular cardiovascular exercise that elevates your heart rate and increases blood flow to the brain and body. Several studies have found an association between physical activity and reduced risk of cognitive decline.

Hit the books - formal educa-tion in any stage of life will help reduce your risk of cognitive decline and dementia. For example, take a class at a local college,

community center or online.

Butt out – evidence shows that smoking increases risk of cognitive decline. Quitting smoking can reduce that risk to levels of those who have not smoked.

Follow your heart - evidence shows that risk factors for cardiovascular disease and stroke, such as obesity, high blood pressure and diabetes negatively impact your cognitive health. Take care your heart, and your brain

might just follow. Heads up! Brain injury can raise your risk of cognitive decline and dementia. Wear a seat belt, use a helmet when playing contact sports or riding a bike, and take steps to prevent falls.

Fuel up right — eat a healthy

and balanced diet that is lower in fat and higher in fruits and vegetables to help reduce the risk of cog-nitive decline. Although research on diet and cognitive function is limited, certain diets, including Mediterranean

Mediterranean-DASH (Dietary Approaches Hypertension) may contribute to risk reduction.

Catch some zzz's - not getting enough sleep due to conditions like insomnia or sleep apnea may result in problems with memory and thinking.

Take care of your mental health

- some studies link a history of
depression with increased risk of cognitive decline, so seek medical treatment if you have symptoms of depression, anxiety or other

to manage stress.

Buddy up - staying socially engaged may support brain health. Pursue social activities that are meaningful to you. Find ways to be part of your community - if you love animals, consider volunteering at a local shelter. If you enjoy singing, join a local choir or help at an afterschool program. Or, just share activities with

friends and family. Stump yourself – challenge and activate your mind. Build a piece of furniture; complete a jigsaw puzzle; do something artistic; play games, such as bridge, that make you think strategically. Challenging your mind may have short and long-term benefits for your brain.

"The worst phase of the matter is that the President has attempted to do these things and failed," the sen-ator said. "This is not a high crime or misdemeanor for two reasons: first, he had full power under the laws of Congress to remove and appoint as he tried to do; and second, if he had no such power, the attempt thus to exercise it is not by statute law nor by common law nor by common sense a high crime or misdemeanor." (Italics by Henderson based upon Senate tran-

Henderson finished with a flourish, saying the Senate should not "surrender our convictions of duty."

"We have been sworn to examine this case from a legal and not a party point of view," he said. "If this were a vote on whether Johnson should be elected President, or whether, being in, he is a fit person for the exalted office, our position might be relieved of much embarrassment. The question is simply one of guilt under the charges...and I cannot, in justice to the laws of the land, in justice to the country or to my own sense of right, render any other response to the several articles than

response to the several articles man a verdict of 'not guilty.''
Henderson had specifically tar-geted the first eight accusations against Johnson. And though the Chicago Tribune said the speech "discouraged impeachment the friends somewhat, Henderson was still non-committal on at least one of the three remaining charges.

On May 11, 1868 – five days before the first vote to convict or acquit -- Henderson had dinner with the senator's vote for acquittal. That drew Chase's ire.

"I have not exerted myself to 'I nave not exerted myself to influence anybody one way or the other," the chief justice wrote in a letter, saying Henderson was a "near neighbor" and adding he was sure he gave the senator "no advice nor sought in any way to control him, and could not if I had." The next day, five of the eight Republicans from the Missouri Congressional delegation paid Henderson a visit. The group included Ninth District Representative George Washington Anderson -- as with Henderson, a lawyer from Louisiana. They "laid siege in due form to their backslid-ing senator," according to Dewitt. "They told him that the position

he had taken on the Impeachment question was against the almost unanimous wish of the 'Union' party of their state, and that violence and bloodshed, they feared, would follow the President's acquittal," Dewitt said.

In response, Henderson said it would be dishonorable of him to change his mind. Then, he shocked them by offering to resign and have Gov. Thomas Fletcher telegraph the name of a replacement "so that by four o'clock that afternoon they would have a senator to their lik-

"The representatives, however, were not satisfied on this point and protested that they did not want his resignation, what they wanted was his vote," the author added.

Henderson asked delegation members to meet and write down what they would like him to do. The letter asked the senator to "withhold your vote on any article upon which you cannot vote affirmatively Again, Henderson said he could not do so without "humiliation and

shame."
Anderson likely understood Henderson's approach. Not only did he know the senator well, but allegations of political chicanery had clouded his 1866 Congressional campaign when Democrat opponent and newspaper editor William Franklin Switzler contested the

Meanwhile, on the night of May 13, the delegation – this time with-out Anderson – took aim at Henderson one last time, insisting "that duty required the senator to cast a vote of guilty on one article, if that vote were found indispensable to secure a conviction," Dewitt said.

attorney in New York City, came to Washington and found his friend's "sense of justice had been affront-ed." The Rock Island, Ill., Argus ran a big headline that declared "Attempt to Henderson." Bully Senator

Whatever momentary melan-choly the senator had felt as a part of offering to resign, Cox's visit

quickly dissipated it.
"This act seems to have restored (Henderson's) usual sense of hon-our and propriety; and he wrote a letter to the representatives of his state, informing them that he could not ascertain the probable outcome of the trial; that he could not, consistently with the obligations of his oath, resign; and that he had resolved to remain at his post and to do his duty as it was given him to know it," Dewitt noted. Henderson also sent what the

Argus called a "noble response" to Fox and his quasi-jurist jackals. "Say to my friends that I am sworn to do impartial justice according to law and evidence, and

I will try to do it like an honest
