leather for a variety of uses. The proximity of battles between federal troops and the Native leader known as Black Hawk forced Mis-

militia. Mase put together the first Company Pike County Missouri

After two weeks of back-breaking work battling heat and mosquitos, the men were tired and grumbling.

"A wagon laden with whiskey, salted beef, bacon and flour arrived fortuitously on July 3," wrote author Mary Ellen Rowe. "Instead of a mutiny, the men rallied to celebrate the Fourth in grand style."

The fort never fired a shot in anger. Miller soon ordered the men to return home. The volunteers offered to stay an additional month, but Miller "wanted the rowdy... Pike men replaced with more reliable companies," according to

Mase and his troops left on July Aug. 27 and Fort Pike was aban-Photo by Brent Engel doned the following month.

Mase went on to serve as a Frankford postmaster and a state representative, and in 1848 ran unsuccessfully for Pike County sheriff. He died at age 67 on June 15,

The site of Fort Pike later was used as a ferry landing. Today, it is a recreational area maintained by the Missouri Department of Conservation near the old St. Francisville bridge.

The Pike County R-III School District has parted ways with Superintendent Mark Harvey. The school board filled the vacancy last Thursday with an interim superintendent, Michael Gray.

Gray retired as the Montgomery County R-II Superintendent last

He worked at the home of the Wildcats since 2011 and had previfrom 2007-2011.

Prior to that, he worked as the superintendent for East Alton School District from 1988-2007 and as a teacher and principal in Illinois.

Due to his retirement, Gray will hold the position until another interim or permanent superintendent is

The former superintendent, Mark Harvey, has been at Clopton since

He served as the elementary school principal until 2010 when he took on the role of superintendent. Prior to working at Clopton, Harvey taught and was an assistant principal at the Ft. Zumwalt School District.

According to Pike R-III School Board President, Christy Kuntz, the board of education and Harvey reached an agreement with respect to the conclusion of his employment

with the District. "It has been my pleasure to serve as superintendent of the Pike County R-III School District for the past eleven years, second in service only to Mr. Joe Henry," Harvey said in a statement he submitted to the school board. "Before being offered the superintendent position, I was able to


who have worked here. This is due to the family-like relationships formed with the many great employees, the student body, and the boards of education that have provided an environment where education comes

First formed in 1955, the LaFemme Arts Club continues to serve Vandalia with beautification projects such as the hanging baskets decorating Main Street.

They work behind the scenes too by raising money and presenting scholarships to Van-Far graduates since the early days of their incep-

In 1980, the group along with other clubs set to the task of building the North and South Railroad Parks. The members were eager to get their hands dirty building flower beds, planting trees, and creating a beautiful park where residents and visitors could relax.

It was the kind of work the group had become known for throughout the community as they primarily focused on Main and State streets.

Fast forward 40 years, the members of LaFemme who range from their late 60's to mid-'80s are ready to see the North Railroad Park revi $talized,\ although-and\ understand$ ably – in more of a fundraising and organizing compacity.

Typically, they raise money for the various projects through two major fundraisers. Like so many others, those events were stalled by the pandemic. Despite that setback and with the generous help of the community, the club managed to

complete their Flower Basket Project in time for spring.

They're looking for the community's assistance as they tackle the next portion of the North Railroad Park Revitalization.

"This area was originally planted in the 1980s and needs a complete to the group's redo," according statement. "It needs new shrubbery, mulch, flowers, and landscape tim-

According to club member, Janie Zimmer, they noticed the park needed help just before Governor Parson's visited last month.

"The governor was coming to town along with all the other dignitaries," she told The Tribune. "This year the park became so overgrown. It was so ugly. Everything was brown, weeds were coming up, and the governor was coming to town the next day. I thought, 'oh my gosh, I'm going to go out and start pulling

Around 4 p.m., that day, she set out to do exactly that, and she wasn't alone for long.

'One of the other club members happened to see me and stopped to help," she continued. "So, we just dug and pulled and when it started to get dark, [her partner] said, 'let me call the guy that mows my

He agreed to help and together they completed the quick project before Governor Parson visited but realized more work was still needed.

Pike County Residents Targeted in 1864 Rampage Editor's note: Following is part ing six soldiers and a few townspeo-

one of a story by award-winning print and broadcast journalist, historian and public relations professional Brent Engel of Louisiana.

James Monaghan heard glass breaking and metal crashing.

The Weekly Union editor was walking in downtown Louisiana around 8 a.m., on the otherwise quiet Tuesday of May 24, 1864.

The Kill List, a secretive inventory of 52 Pike County residents targeted for murder because of their alleged Southern sympathies in the Civil War, had just been drawn up.

Because the document apparently has not survived, it isn't clear if the newspaper writer was included. But he certainly opposed its lethal aim, and many on both sides would have loved to silence him and another local editor.

Monaghan strode from the street up the stairs to the Union's secondfloor office. He later described seeple ransacking the place. The editor demanded an explanation before ordering them to leave.

Just then, a shot rang out. The bullet missed its mark, but several men pounced on Monaghan and beat him before he was able to escape to a friend's house.

"Presses were broken and thrown out of the windows, type was scattered on the streets and everything was destroyed within reach of the infuriated mob," according to the 1883 book "The History of Pike County, Missouri" Damage was estimated at would be almost what today

After a couple of hours, the firebrands took a break and went to the riverfront as the steamer Keokuk docked. Several agitators boarded the St. Louis-bound riverboat, but others remained on the wharf. They still had destruction in mind. This time, the target was the office of A.J.

Reid, the brilliant but cantankerous editor of the Louisiana Journal.

Reid had been combative since taking over the paper in May 1859. Early in the war, he unabashedly supported the Union, but believed President Abraham Lincoln would be ineffective in healing the nation.

Reid's caustic and provocative editorials could irritate pro-Union and pro-Confederate forces alike. Much to the chagrin of Southern supporters, he once suggested that a slave who escaped from a Pike County tobacco farm had made abolition "practical." Another time, the target was peace-at-all-costs Unionists – called "Copperheads" – who were urged to "Crawl to your everlasting holes!

Just three days before his office was attacked, Reid had offered harsh words for rebel sympathizers while equally criticizing those who sought "under the garb of Unionism to defy



Edward Lynn Clary, 86, of Silex died Monday, May 24, 2021 at his home.

Cremation rites are under the direction of Bibb-Veach Funeral Home and Crematory of Bowling Green. Services will be held at a later date.

Edward was born Aug. 18, 1934 in Menfro to Edward Lee and Hilda Marie Stueve Clary-Kluender. He was united in marriage to Eleanor Marie Lauck on Nov. 27, 1964. She survives.

Edward moved to Brazeau as a child, where he lived with his grand-parents. He also lived in Kansas City and St. Louis before moving to Silex. Edward worked for Lionel Moise, Inc., in St. Louis until he started roofing with Biebel Brothers Roofing of St. Louis. At this point, he also joined the Local Union 513 and Local 2, where he was a member until he retired the profession. He then began his second career with the Lincoln County Road Crew until he retired permanently.

Throughout his life he also farmed. 
This isn't about what is best for this school district, this appears to be about personal agendas, revenge, and egos.

It isn't heaven, but it must be pretty

A woman who has been making fudge and sending it to military personnel around the world since the Vietnam War will be one of the speakers at the Tri-State Housing Summit Monday, June 10 in Hannibal.

Vickie Hansen was part of the weatherization program administered in 12 Missouri counties by the not-for-profit North East Community Action Corporation (NECAC), which founded the summit in

"I give the military hope," Hansen said.
"A lot of times, they're not appreciated. I let them know 'We do care about you and you're important."

Hansen's effort was handed down from her family, which made treats for service people during World War II. Her tiny kitchen is filled with delectable scents 10

hours a day, seven days a week from October to July.

All told, she produces about 42,000 pounds each year. That's right, 21 tons as much as a fleet of Chevrolet Chevettes. two dozen polar bears or 231 pickup truck beds full of sand. The 71-year-old dynamo claims she's "nothing special," but everyone from privates to generals would

"My fudge isn't any better than anyone else's, but I put hope and love in it," she said. "I have fun with it."

Hansen creates 23 flavored varieties and 13 that contain alcohol, stirring each batch by hand in an iron skillet. The secret Irish recipe has been in her family for generations and the book in which it's written remains hidden from all but the most trusted visitors.

Of course, Hansen doesn't need a

Woman Known For Confections To Speak At Housing Summit primer. She will acknowledge that every cluster of confectionery bliss starts with three cups of sugar, melted butter and marshmallow cream before other ingredients are added.

Some people tend to slow down as they grow older. Not Hansen. After retiring as a paralegal and a certified nurse's assistant, she found that her fudge output

These days, each shipment to active, inactive or retired military personnel contains 25 pounds. Donations help offset some of the costs, but Hansen pays most of the bill for ingredients and shipping in tin containers or foam coolers. She's gotten as many as 60 telephone calls in a day at all hours with orders or "thank yous." Hansen calls recipients her "kids."

The military is a strong tradition for Hansen. Her father and two of her four children among other relatives served the country.

NECAC Weatherization supplied new windows, upgraded doors and insulation at Hansen's home. The natural gas company Spire provided additional work. They were fabulous," Hansen said. "They did a great job."

The Housing Summit is open to the public, but seating is limited and reservations are requested. More information is available by calling NECAC at 573-324-6622. defy the law, to gratify personal hate and satiate the meanest passions."

Though he avoided mentioning The Kill List directly, Reid's words speak to its intent. He called such loyalty "spurious and detestable."

"And if to denounce lawlessness calls upon our heads the opprobrium of giving comfort to and currying favor with the rebels, we shall only pity the man who so far misunderstands what loyalty is," Reid charged.

The editor had been pilloried by Lincoln backers for his support of Union Gen. George McClellan in the presidential election that was a little more than five months away.

Reid said his loyalty was "of a higher type than that craven mercenary stuff which induces its possessors to endorse every wrong act" in the name of Union victory. He added that "too many men have appropriated the name of Unionism for base purposes" and were doing little more than trying "to gratify old grudges."

The Journal missed its regular May 28 publication date, but thanks to "extra exertions" it hit the streets

again on June 4. The only apology Reid offered was that he was not "in the most amiable frame of mind" when writing an editorial the day after the destruction.

In it, he put blame squarely upon radicals and said the paper would continue to decry disorder long after the "breeders of mischief" had been "buried in that deep pit of infamy, to which a virtuous and loyal people will justly consign them.'

In addition, Reid defended Monaghan by calling his competitor "a thorough Union man" and said "nothing disloyal has ever appeared in his paper."

A quick response was issued by another Louisiana paper, the True Flag, which was edited by 25-yearold Union conservative Clay Crittenden Menefee Mayhall.

The rebels "will even have their apologists in the press of our county, as they have already had in times past," Mayhall wrote. "The records of our county prove that one press in our city is owned either directly or indirectly, in whole or in part, by rebels of well-known dye.

Journal readers caught up in the drama might have been forgiven for missing a Page 3 blurb in that June

4 edition. It was much more sinister. Next time: The first killing.

"That's where we are right now. We're just want to kind of start over and make it pretty again.'

Along with Jean Barnes, the two members talked about how the club formed and some of its early history within the community. They also explained their plan for tackling the park

Others have completely disappeared. It's a problem echoed throughout the area and the country as clubs and charitable groups face a decline in member-

"People aren't really organizationminded anymore," Jean added.

We did the flower boxes and got ready for the brick skid, then planted trees in one of the parks - Bradford Pears which now we find out are horrible trees and everybody wants to get rid of them, but that's another project," Janie explained as both women browsed through pages of newspaper clippings and various photos collected in the club's scrapbook.

'We honestly have spent hours and hours in town with our butts in the air,' Jean joked and pointed to one picture of a group of ladies around a bed of tulips. We planted those near the stop sign. That was beautiful but it's not as much work as what we're talking about here."

They don't plan on taking on the brunt of manual labor this time. At the previous club meeting, the group decided to move forward.

'We want to tear everything out of both parks, but we're starting with the North park," Janie continued. "So, we want to get everything out and we've got a man that's willing to use machinery to

get rid of it for us. We're really tickled about that. It's quite a project for 80-plusyear-olds," she laughed. "We're just to the point where we need help.

They hope to meet a goal of \$1,500 for the project. It's a modest amount for a park project but at the time of the in-
