I got a ride I'll never forget-it was in a 1969 Dodge Charger owned by my dad's friend, Bill Hall. The sound of the engine, the speed, the squealing of tires-it left a last-

ing impression on me. Right after that ride, I turned to my dad and said, "I've got to have one when I turn 16.

When I was 15, I started asking my dad about getting a Charger. Not long after, he came to me and said he'd found one for sale-a 1970 Dodge Charger 500. We drove out to see it, and it was love at first sight. The car had belonged to Harry Twellman of St. Clement, who originally bought it from Shaon Motors in Bowling Green. I paid \$900 of my own hard-earned money for it, saved from helping my grandpa on his farm. Every dollar went toward that

time, I kept myself busy working on the car. I started cleaning it up, added an AM/FM 8-track stereo and speakers, and began making it my own. The paint and interior were rough, so I had it repainted by Earl "Smitty" Smith, and his wife, Martha Smith, did the upholstery work. They helped bring the Charger a step closer to what I had imagined from the start.

take Or Murder?

Former Louisiana Mayor Dies After Shooting BY BRENT ENGEL

Questions surrounded the 1915 death of former Louisiana Mayor Alten Walker at the hands of Fred Wilkins.

The biggest was if it was accidental or deliberate.

The case drew widespread attention because the victim was on the staff of Missouri Gov. Elliott Major, a Pike County native.

"This little city is torn with excitement," The Quincy Whig said. Reporter Perry C. Ellis treated readers to a poetic aside, saying there "are circumstances and facts surrounding the deed itself, whether it was involuntary or not, that draws closely about it the tapestries of tragic mys-

Local newspapers tried to quell suspicions.

"True, there is a mystery about the shooting, which has not been satisfactorily explained, and the public...imagines and talks the worst for it, the Pike County News wrote "But there have been many wild, unfounded and untrue rumors spread about the case that are quite unfortunate and do no one nor the community any good."

Alten Mudd Walker was born in Pike County on Sept. 8, 1868. He taught school and worked at the post office before becoming a real estate and insurance agent. In 1890, the Democrat was elected clerk of the Louisiana court of pleas. The following year, he married Lillie Jackson. The couple's home was on Tennessee Street.

In 1893, Walker bought the Mitchell & Matson abstract business at the corner of Third and Georgia and set up an office. John Welburne Matson called him "thoroughly honest and untiring."

Some began to wonder after

an investigation in 1894 found that Walker had not forwarded to the county a little over \$254 in court fees - more than \$11,500 today. Walker, one of at least five

elected officials named in the query, paid back the money immediately and was not charged. However, there would be more legal trouble in the vears ahead. As the new century dawned,

Walker was elected mayor and served until 1909. He was shot on Tuesday, March 2, 1915.

Accounts vary, but it happened sometime after 9 p.m. Walker and Wilkins each swore it was an accident that took place at Walker's office The testimony of others indicated Walker might have been wounded before the two men got there. Fred Daniel Wilkins was a

Louisiana native and a fellow real estate agent who had once worked in Walker's office before setting out on his own.

'So far as is known, the business separation was amicable, and so far as anyone knows there has never been any trouble between the two men," The Whig said. Wilkins had returned to

Louisiana in late 1914 after living in Hannibal, and was occupying a home on North Third Street owned by Walker's mother-in-law. Eliza Jackson. Dr. James William Crewd-

son told investigators he was at the Elks Lodge when he got a call from Walker at 9:10 p.m.

saying he had shot himself. Conveniently, the doctor's office was next door to Walker's. The bullet had entered the

left side about one inch above the navel and six inches to the side of it," the News reported. "There was only one bullet wound, but it made eight lacer-Walker said he and Wilkins

were examining the .38-caliber revolver when it inexplicably fired. Soon, others who heard about the incident gathered. One of them was Erasmus "Ras" Pearson, a Louisiana attorney who had previously represented both men. He told Wilkins, who owned the gun, to keep his mouth shut.

Despite being in pain, Walker had no qualms about talking. He "called a number of those who were there to him and said that if the worst comes, I want all of you fellows to understand that this is an accident and no one is to blame," the News paraphrased.

Walker was taken home and his wife was summoned from St. Louis, where she had been visiting. Wilkins spent the night and offered "whatever service he could render." The Whig reported. Crewdson said there was "very little" hope of recovery. Walker died at 3:20 p.m. March 4 and was buried in Riverview Cemetery on March 7.

Wilkins attended the funeral and was "greatly distressed,' according to The Louisiana Press-Journal. It may not have just been sorrow. The Quincy Daily Herald reported "the web which is being woven around his liberty is growing tighter."

Pike County Coroner James Hendrix called an inquest for 10:30 a.m., March 8 at city hall. The Whig said the sixman panel hoped "to clear the mysterious circumstances that surround the killing.'

Staff and students' family members were only recently informed of the yesterdays decision to close 12 schools around the state for the severely disabled.

Lillian Schaper State School in Bowling Green is among the list that will be permanently closed by the end of the 25/26 school

According to a staff member, the school currently serves 12 students

(grades K-12), although that number fluctuates. There are also around six staff members employed at

The school has had a long history in Pike County and Bowling Green. The Pike County Agency for Developmental Disabilities website documents the school as being originally

founded in the 60's.

"Pike County has a long history of leading the way in caring for its citizens who have developmental disabilities," the organization wrote in a history of the High School in 1960. school. "Starting with a group of parents, family members and interested citizens, the Champ Clark

Association for Retarded Children was founded in the 1950's. It functioned as a parent support group and led to Pike County parents becoming aware of and involved in what was going on around the State. In 1955, four mothers of children who had intellectual

disabilities and no school to attend approached Mrs. Ruth Jensen, county superintendent of schools, and requested her assis-

The organization goes on to document the birth of the school which started as classes in the basement of the abandoned Bowling Green Elementary/Junior

"The school moved, in 1972, to two trailers set up on land at the new Ruth Jensen Village," the website continued. "After outgrowing the trailers, a brand new school, Lillian Schaper State School No. 14, was constructed in 1974. The school was named after Mrs. Lillian Schaper of Bowling Green, who worked tirelessly for the school children.'

That history did not affect Missouri's Department of Elementary and Secondary Education's (DESE)

as well as names and dates.

The Wentzville woman and Clarksville native is preserving her family narrative in the book "The Mackeys of Pike County Missouri.' "I want my kids to know

their heritage" Rodhouse said. "It's something I can leave An incredible tale it is. The

first Mackeys to arrive in Pike County in the early 1800s were brothers James, John and Thomas, who lived in Tennessee after coming from North Carolina when their father

The brothers and their sons began buying land from the federal government for \$1.25 an acre. Most of it was west Alice Rodhouse with a copy of her book "The Mackeys of Pike County, Missouri." of Clarksville in an area that became known as Mackey Valley.

Only two of those original land grant farms remain in the Mackey family and Rodhouse owns both of them. Her granddaughter lives on one – which was bought by the son of James and her son, David (sixth generation) lives on the farm bought by the son of Thomas in

The log house that Thomas Jr. built still stands there and a Mackey gathering will be held at the site on Aug. 31 to celebrate the farm's bicentennial.

Rodhouse admits her book is not meant for genealogical research. Rather, it is stories of the family.

Included are tales of the August 1841 murder of Reason Mackey and the execution of his killer - supposedly the only hanging at the courthouse – and the January 1818 marriage of Jennie Mackey and James Templeton, the first recorded in the county. The book also has stories of the Mackeys as farmers, merchants and politicians.

Rodhouse encourages others to chronicle their family histories.

'If you like to do it, it's fun," she said. "If you don't, you'd better get someone else

ISS Confirms Rare Case Of Bra

The Missouri Department of Health and Senior Services (DHSS) is announcing case of an adult Missouri resident with a laboratory-confirmed infection of Naegleria fowleri.

Naegleria fowleri is a microscopic single-celled freeliving ameba that can cause a rare deadly infection of the brain called primary amebic meningoencephalitis (PAM), also known as "brain-eating" infection. Typically, fewer than 10 people a year in the United States get PAM.

The Missouri patient is currently being treated for PAM in an intensive care unit of a hospital, and currently, no additional suspected cases of PAM are being investigated in Missouri.

The ameba is common and naturally present in warm freshwater such as lakes, rivers and ponds; however, PAM is extremely rare. Between 1962 and 2024, there were 167 reported cases of PAM in the United States.

The source of the patient's exposure is currently being investigated by public health officials. While not confirmed, preliminary information implies the patient may have been water skiing at the Lake of the Ozarks days prior to becoming ill. Recreational water users should assume that Naegleria fowleri is present in warm freshwater across the United States; however, infection remains very rare.

Although a rare occurrence, people become infected by Naegleria fowleri when water containing the ameba enters the body through the nose from freshwater sources. The Naegleria fowleri ameba then travels up the nose to the brain where it damages the brain tissue. This infection cannot be spread from one person to another, and it cannot be contracted by swallowing contaminated

People can take actions to reduce the risk of infection by limiting the amount of water going up the nose. These actions could include:

Hold your nose shut, use nose clips, or keep your head above water when taking part in activities in bodies of warm freshwater,

especially if you jump or dive into the water.

Avoid putting your head under the water in hot springs and other untreated

thermal waters. Avoid water-related activities in warm freshwater during periods of high-

water temperature. Avoid digging in, or stirring up, the sediment while taking part in water-related activities in shallow, warm freshwater areas. Naegleria fowleri amebas are more likely to live in sediment at the bottom of lakes, ponds and rivers.

Those who experience the following symptoms after swimming in any warm body of water should contact their health care provider immediately as the disease progresses rapidly: Severe headache.

Fever. Nausea. Vomiting. Stiff neck. Seizures.

Altered mental status. Hallucinations.

MU Extension, MDC Continue Free Oak Testing University of Missouri worsens over several years.

Extension's Plant Diagnostic Clinic, in partnership with the Missouri Department of Conservation, continues to offer free testing for all common oak tree diseases in 2025.

"We had a great season in 2024 as we received a total of 93 oak samples and diagnosed diseases including oak wilt, bacterial leaf scorch, tubakia leaf spot, anthracnose, cicada damage and so on," says Peng Tian, director of the Plant Diagnostic Clinic on the MU campus. "This allowed us to mon-

itor the prevalence of the common disease currently in Missouri and scout for new or invasive diseases of oaks to better assist MDC and the Missouri Department of Agriculture with controlling forest pest problems," Tian says. "With this service, we hope to continue collecting information on the location and host species of oak diseases across the state and monitor the tree health of the state."

Oaks are the most abundant trees in yard and forest settings across Missouri. Two common oak diseases are bacterial leaf scorch and oak wilt. Oak wilt weakens white oaks and kills red oak trees within weeks of infection. Bacterial leaf scorch is a chronic disease that Both diseases spread to nearby oaks.

Oak wilt symptoms first appear in late spring or early summer in red oak. Leaves discolor, wilt and fall, first at the top of the tree and later at the tips of lateral branches. Leaves turn a dull, bronzed brown at the tips and along the outer margins. Similar symptoms appear in white oak trees in mid-to-late summer. Trees infected for two or more years commonly develop isolated dead branches in the crown.

Bacterial leaf scorch infects the xylem of susceptible trees and prevents transport of water and nutrients. There is no cure for bacterial leaf scorch on oak, and trees die in 5-8 years. Symptoms are like those of drought stress and can only be diagnosed by laboratory analysis. If you suspect either dis-

ease in your trees, Tian recommends sending a sample for testing and confirmation to the diagnostic clinic.

First, send 3-5 photos of the tree to the clinic through digital sample submission. Go to https://muext.us/ PlantClinicDSS for instructions. Tian suggests submitting both close-up photos and photos from a distance.

"MU Plant Diagnostic Clinic staff will contact you regarding the physical sample submission guidelines depending on the tree health problems observed in the

photos," he says.

For bacterial leaf scorch testing on oaks, select leaves that are still green but show leaf scorch symptoms. Collect 20-30 leaves with the petiole (leaf stem) attached and pack them in a sealed plastic storage bag with a damp paper towel. Keep the leaves cool.

For oak wilt testing, collect 20-30 leaves and 4-6 branch sections that are about 8-12 inches long, roughly 0.5-1.5 inch in diameter, and are alive but showing symptoms of leaf wilt. Keep samples cool, but

do not freeze them, says Tian. Infected samples that get hot during transit to the lab may not test positive for the fungus. For both tests, he recommends contacting the lab

MacLaughlin Competes In USA Swimming Gracey MacLaughlin, 17-


year-old senior student at Clopton High School and member of the Twin Pike Family YMCA Torpedoes Swim Team, recently competed in the USA Swimming TYR Futures Championships in Madison, Wisc.

This event is a stepping stone meet for the Junior Nationals. If Gracey can meet qualifying times before she turns 19, she can move on to the Junior Nationals. This would open the pathway for the Senior Nationals or World Champions which is the Olympics in an Olympic year.

To qualify for the Futures meet this year, Gracey dropped three seconds off of her 100 backstroke. As swimmers move up in the ranks, it becomes more difficult to drop time making this a significant accomplishment. Gracey will only need to drop one more second to qualify for the Junior Nationals next season. She also dropped five seconds off her 200 backstroke and needs to only drop three more seconds to qualify. Gracey is targeting those qualification times for the USA Swimming Short Course Winter Junior Nationals this December.

Gracey has been competing in swimming events since she was six and has many regional and national events under her swim cap. This summer she competed at a Speedo Sectionals meet at the University of Missouri - Columbia.

During the winter season, she also competed at the Heartland Area Central Regional swim meet, the Heartland Area Championships, MSHSAA Class 1 State Championships, and



pionships. At the Heartland Area Championships, she earned first place in all events in which she swam and broke long-standing Area Championship records in the 1000 yard freestyle and the 200 backstroke. Gracey will be swimming

for the Louisiana - Clopton Co-op High School Swim Team this winter. In the offseason for this team, she will be swimming for the Twin Pike Family YMCA Torpedoes. This recommendation was made by the Missouri Department of Elementary and Secondary Education (DESE) during the August 12 Board meeting. DESE leaders presented possible solutions to the Board in May to improve services at MSSD. Those solutions were designed to strengthen educational opportunities for both students currently enrolled within MSSD along with all students with extensive support needs (ESN) throughout Missouri.

The initial step in reimaging the MSSD is reducing the number of locations over the next year.

The board voted to:

• Permanently close six buildings that were already temporarily consolidated due to staff vacancies, effective immediately. Those locations include Briarwood (Harrisonville), Lakeview Woods (Lee's Summit), Gateway/Hubert Wheeler (St. Louis), Rolling Meadow (Higginsville), Delmar Cobble (Columbia), and Ozark Hills (Salem).

ditional buildings by the conclusion of the 2025-26 school year as a proactive approach to addressing additional challenges in those buildings and regions that would otherwise likely result in emergency consolidations in the future. Those locations include Citadel (Potosi), College View (Joplin), Crowley Ridge (Dexter), Dogwood Hills (Eldon), Lillian Schaper (Bowling Green), and Prairie View (Marshall).

Throughout the last two years, DESE worked with Public Consulting Group LLC (PCG) and Capital Asset Engineering to independently evaluate the operational and educational programming of MSSD to ensure students within the program receive the highest quality educational opportunities. In September 2024, a Long-Range Planning Advisory Committee (LRPAC), made up of more than 50 stakeholders, was established to review the findings of the PCG study and make recommendations to the Board.

LRPAC identified many strengths among MSSD's work, including staff and leadership who are supportive and knowledgeable and team members who provide a caring environment for students. The LRPAC also recognized

several unique challenges MSSD faces: · Enrollment: MSSD has experienced a 36 percent enrollment decline

during the last 16 years (1,033 to 660 students statewide).

• Staff recruitment and retention: There is currently a 23 percent vacancy rate among MSSD staff (115 vacant positions), along with a high turnover rate

in MSSD leadership roles. · Facilities: Most MSSD students are being served in aging facilities that were not designed to serve students with ESN. Many buildings also do not
